# BACKGROUND

Within Alliance Manchester Business School (AMBS), the Division of Accounting and Finance is one of the leading, and also one of the largest, accounting and finance units in Europe and the world, with an outstanding track record of excellence in research and teaching. The Accounting group has considerable research strengths in the areas of auditing and accountability, financial reporting, management accounting, and market-based accounting, with faculty publishing in top journals such as Accounting, Organization and Society, Contemporary Accounting Research, Journal of Accounting Research, and The Accounting Review.

At the postgraduate level, the Division offers a wide-ranging set of specialist MSc degree programmes in both accounting and finance, as well as contributing to MBA and executive education programmes. At the undergraduate level, the Division makes significant contributions to AMBS' undergraduate programmes in management and in accounting and finance together with the School of Social Sciences. ### Key Responsibilities, Accountabilities or Duties:

The posts require the successful candidate to:

- 1. Pursue an active programme of high-quality academic research leading to publications in top journals in the field of accounting. We welcome applications from candidates undertaking research in all areas of accounting, although expertise in the areas of auditing or market-based accounting would be considered a plus.
- 2. Contribute to, develop and deliver excellent teaching in and across the general area of accounting. Ability to teach auditing or market-based accounting related courses would be a plus.
- 3. Engage actively in the division by attending seminars and other divisional activities regularly, as well as meeting with seminar speakers and research visitors to the division.
- 4. Undertake other academic and administrative duties as required by the Head of Division.
- 5. Supervise graduate students.

At AMBS, the workload allocated to teaching/administration work during the first years in position is generally low and very competitive compared to other European schools.

### Person Specification for Lecturer positions:

- 1. A completed (or close to completion) PhD (or equivalent) in Accounting or a related area, prior to commencing employment.
- 2. Evidence of the ability to publish in world-leading journals appropriate to the candidate's field of research.
- 3. Experience of teaching at university level and/or evidence of high-quality presentational skills, demonstrating the candidate's ability to offer high quality and varied teaching in accounting as taught in the School's courses. Ability to teach auditing or market-based accounting related courses would be a plus.

- 1. A demonstrated record of research excellence in accounting as evidenced by, for example, publications in world-leading journals.
- 2. A proven ability to offer high quality and varied teaching within the fields of accounting, including at the postgraduate level.
- 3. Evidence of ability to successfully supervise graduate students.
- 4. The ability to provide academic leadership to junior staff and graduate students, and the ability to collaborate with other colleagues within the Division and the School.
- 5. The ability and willingness to contribute to the administration within the Division and the School.
